Contract : This Foster Contract ("Contract") is made effective on the Beginning Date indicated below, by and between Zani's Furry Friends ZFF, Inc (ZFF) and (the "Foster") as indicated in the name field above. Zani's Furry Friends ZFF, Inc and Foster are individually a "Party" and collectively the "Parties" to this Contract. Foster has agreed to foster and care for the pet described below (the "Pet"), and Zani's Furry Friends ZFF, Inc has agreed to release such Pet to Foster, subject to and in accordance with the following terms and conditions:

Care of Pet: The Foster hereby expressly agrees to, and shall strictly comply with, the following terms, conditions, and obligations relating to the care of the Pet:

- 1. To accept and consider the dog/cat as a household companion, not as an outside pet, and to provide him/her with humane care and treatment, including proper food, water, shelter and exercise, and to give him/her a reasonable amount of time to adjust to new surroundings.
- 2. To provide emergency medical/veterinary care for which the Foster will be fully reimbursed upon proof of payment.
- 3. To safeguard the dog/cat from loss or mishap.

- 4. Foster will not permit the Pet to run at large or become a public nuisance. Foster will keep means of identification on the pet at all times.
- 5. In the event that the pet becomes lost, Foster shall make immediate and serious efforts to locate and claim the pet. Foster will immediately contact ZFF (info@zanisfurryfriends.org) as well as PetAmberAlert (https://www.petamberalert.com/) and PawBoost Lost and Found Pets (https://www.pawboost.com/) as well as Foster's local Center for Animal Care and Control, vet and shelters.
- 6. NOT to give or sell the Pet to another person, relative, rescue group, humane association, shelter or pound, or any medical or experimental laboratory or similar organization.
- 7. NOT to change or alter the dog/cat's appearance in any way, shape or form (e.g., cropping, docking).
- 8. Foster shall immediately notify ZFF in the event of death during the foster care period.

- 9. To allow ZFF to make periodic visits for as often as it deems it necessary.
- 10. To immediately notify ZFF of any change of address or telephone number or of any plans to move out of the State of New York during the foster care period.
- 11. To immediately notify the ZFF of any change in circumstance which may prevent me from completing the time period agreed upon under this foster care agreement.

Health: Foster understands that the Pet has been checked, spayed/neutered and vaccinated by a licensed veterinarian and that his/her state of health is accurately represented to the best knowledge of ZFF, however no representations are made as to the temperament or mental disposition of the Pet.

Option To Adopt: If Foster decides to permanently adopt the Pet, Foster shall notify Foster Coordinator and upon approval, shall follow established adoption procedures including signing an Adoption Contract and paying the Pet's adoption fee. If Foster finds a permanent/adoptive home for the Pet, Foster shall notify ZFF and upon approval, shall follow established adoption procedures.

No Warranty: Foster acknowledges, understands, and agrees that ZFF makes no guarantees, promises, representations, or warranties whatsoever, express or implied, written or unwritten, regarding the Pet's disposition, temperament, and/or current or future health and personality. The Foster agrees to take the Pet as is and with any and all faults.

Assumption of Risk; Release; Indemnity: Foster acknowledges that that, due to the unpredictable nature of animals, there are certain inherent risks and dangers associated with the care and custody of the Pet. Foster voluntarily agrees to assume full responsibility for all such risks and waives and releases, ZFF and its directors and representatives from any and all claims, losses, liabilities, injury, or damages of any kind. Foster also agrees to be solely responsible for any actions of the Pet and agrees to indemnify and hold harmless ZFF and its owners, volunteers, and representatives from any liabilities, injuries or losses caused by the Pet or any causes of actions, claims, suits or demands that arise from such injury, damages or losses.

Foster is fully aware of, understands and agrees to all the terms and conditions of this RELEASE AND INDEMNIFICATION PROVISION, and that it is BINDING AND ENFORCEABLE BY LAW.

THE UNDERSIGNED PARTIES HEREBY CERTIFY THAT THEY HAVE READ THIS ENTIRE CONTRACT AND FULLY UNDERSTAND ALL THE TERMS AND CONSEQUENCES OF THIS CONTRACT AND, BASED UPON SUCH, EXECUTE IT.

I have read and fully understand the terms and conditions of this agreement, and agree that it is not arbitrary and that the provisions herein are common in pet foster care agreements. I further understand that if I fail to comply with any of the terms specified herein, Zani's Furry Friends ZFF, Inc has the right to reclaim the Pet and to pursue any legal channels to do so.
